

ORDER FOR HIGHWAYS

We the Commissioners of Highways for the Town of Beloit met at the center of Section 32 this 14th day of March 1848 at three o'clock P.M. to take into consideration the subject of the application of A. J. Battin and five others for discontinuing a highway.

And we certify that after it was proved to our satisfaction by the affidavit of Jacob I. Banter, that notice of our meeting at such time and place had been given as the law requires we examined the ground on the line hereinafter described and we order that the highway laid out on the first day of September in the year 1843 commencing 1 1/2 rods East of the quarter section post in the South line of Section 32 and running North 2° East parallel with the centerline of said section 25 1/4 rods to the center of the highway leading from the Village of Beloit to Monroe, be discontinued.

ORDER FOR HIGHWAY
ROAD FROM JANESVILLE TO BELOIT

We the Commissioners of Highways for the Town of Beloit met at Hackett's store in the said town this 2nd day of September A.D. 1848 at nine o'clock A.M. to take into consideration the subject of the application of John Atchley and five other for the alteration of the highway leading from Beloit to Janesville on the West side of Rock River. And we hereby certify that upon being satisfied by the affidavit of C. M. Messer that notice of our meeting at such time and place had been given as the law requires. We proceeded to examine the ground on the line of the proposed alteration and caused a survey and description of the line to be made which runs as follows:

From the center of the South end of 4th Street in Hackett's Addition to the Village of Beloit North 1° East in the center of said street 9311 links to Hackett's and Lawrence Addition to Beloit; thence North 2 1/4° East in the center of 4th Street 3986 links to the line between Sections 26 and 35; thence West on said section line 1003 links to the center of 4th Street in Noggle's Village Plat. (Not recorded); thence North in the center of said 4th Street 9050 links to the North end of 4th Street; thence North 10° West 3550 links to the point where the highway from Beloit to Janesville laid out June 3rd, 1844 crosses the North and South quarter section line in Section 26 being 100 links South of the Southwest corner of Lot 1 in said Section 26.

And we hereby order that the highway from Beloit to Janesville laid out June 3rd, 1844 be so altered between its 1st and 4th angles that the above described line shall be its center. And the above described line shall be the centerline of a highway.
