# PUBLIC SAFETY & JUSTICE COMMITTEE Minutes – May 19, 2014

<u>Call to Order</u>. Vice Chair Brill called the meeting of the Public Safety and Justice Committee to order at 4:00 P.M. on May 19, 2014 in the Conference Room N-1.

<u>Adoption of Agenda</u>. Vice Chair Brill said there are two Pre-Approved Encumbrances handed out to 5.D. Supervisor Knudson moved approval of the agenda with these additions, second by Supervisor Fell. ADOPTED.

<u>Adoption of Minutes</u>. Vice Chair Brill said an amended set of minutes was handed out and they would be acting on these. Supervisor Fell moved approval of the amended minutes of May 5, 2014, second by Supervisor Wiedenfeld. ADOPTED as amended.

<u>Citizen Participation, Communications, Announcement, Information.</u> Vice Chair Brill said a report from the Sheriff's Office was handed out on alcoholic beverages sold to minors, which Supervisor Wiedenfeld had requested at the last meeting.

Mr. Farrell said he had attended the Rock County Memorial Service for Law Enforcement Officers lost in the line of duty. He said it was a very moving ceremony.

Mr. Farrell said this is Emergency Medical Services Week and he wanted to take this opportunity to thank all first responders for their service to Rock County citizens.

Mr. Farrell said, based on information he had gathered from various agencies dealing with suicide attempts, there were 692 calls for help last year. The average suicide rate for a county our size is 50 per year and our suicide rate is less than half that, much of it is due to personnel at 911 and Crisis. He added there have only been four suicides so far this year. He said we all need to continue working together to keep these numbers down.

Ms. Pohlman McQuillen handed out copies of a flyer for the Community Resource Fair on June 5, 2014 from 1:00-3:30 PM at the Job Center and encouraged everyone to attend.
