- B. Arrive at 9:50 am. Indianford Stormwater Management Site.** Sections 16 & 21, Fulton. Observe a proposed storm water/erosion control management project conducted by Alliant Energy under a Utilities General Permit.
Depart at 10:10 am.
- C. Arrive at 10:15 am. Yahara River Bank Protection.** Section 18, Fulton. Discuss Yahara River Bank Stabilization Project Past, Present, and Future. **Depart at 10:35 am.**
- D. Arrive at 10:50 am. Vanthournout/Phelps PACE Easements.** Section 13, Union. Discuss PACE Program Easements for Greg Vanthournout and Candice Phelps. We will discuss a Civilian Conservation Corp Erosion Control Structure located on the north end of the Vanthournout Property. We will review Grassed Waterways/Erosion Control on Candy Phelps Property. **Depart at 11:30 am.**
