## 4. Secretary's Report

Mr. Somppi presented a draft of the newest application for owner occupied rehabilitation assistance. The updated application provides a more comprehensive method of verifying and determining customer eligibility. The additions or changes to the previous application are due in large part to increased federal requirements.

Mr. Somppi presented the 2014 expense line items for the Housing Authority that are contained in the adopted 2014 Community Development Budget. There was little change from the 2013 budget other than increasing the amount to the per diem line to cover more meetings for the year. The Commissioners suggested that, if funds were available, a Commissioner be included to attend the annual State Housing Authority Association Meeting.

Com'r Beaver moved the approval of Loan 006101D1 in the amount of \$27,768; seconded by Com'r Grahn. All in favor – **APPROVED** (Yes – 5, No – 0, Absent – 0)
