

Executive Summary

The Information Technology department included funds in the 2020 budget to invest in the training of its staff. As referenced in the Baker Tilly audit, many staff members have not been provided training opportunities in several years. This was viewed by the audit as a weakness within the department, and that professional development should be part of the overall IT strategy.

StormWind Studios is a company that provides online training on a large variety of IT material, including: Microsoft, Linux, VMWare, Project Management, and Cisco, among others. The training service being offered allows IT staff unlimited use of the training platform for two years.

Access to this training allows staff the opportunity to refresh their skillset and for staff to be able to cross-train on applications less familiar to them. This provides better sustainability within the department.

The subscription is available from SHI International Corp under state Contract: #505ENT-M16-VARSOFTWARE-03.

The requests for funds for this purchase were included in the 2020 Rock County budget.
