Neil Deupree of 419 S. Franklin Street, Janesville invited the public to the 'unveiling' of the MLK Jr. Memorial Hwy signs on Monday, January 18th at 10:00 am. Parking will be available at Prairie Avenue Concrete.

10.A. Update on Wisconsin and Southern Railroad – Ken Lucht.

Ken Lucht presented to the board on the current state of the Wisconsin and Southern Railroad Company. Mr. Lucht explained that of the over five million dollars in ARRA funds that were dedicated to improving the country's infrasctructure, no monies were dedicated to freight rail. Wisconsin and Southern Railroad Co. owns over 600 miles of track, delivering product to over 14 industries which employs more than 600 people. The company was recognized in 2009 with the Regional Railroad of the Year award. Mr. Lucht explained that the single largest challenge for the railroad is the updating of the infrastructure. Only 12% of the existing track is compatible by today's standards and much rehabilitation and upgrades are necessary to improve the speed and safety of freight delivery on the existing rails. A map that included shovel-ready projects for three lines (Whitewater to Madison; Slinger to N. Milwaukee; and Brodhead to Avalon) was distributed to the Board. This map included statistics and details should economic stimulus become available for capital rehabilitation projects. Another map that explained "Grow Wisconsin" was also distributed. Mr. Lucht answered questions from the board and offered a tour of the rail lines if enough interest is expressed.
