#### **EXECUTIVE SUMMARY**

Authorizing the Purchase of Power Transport Cots and Maintenance Agreement

The Medical Examiner's Department 2022 approved budget contains the purchase request of Stryker Power Transport Cots and Maintenance Agreements.

Research was conducted on using power transport cots as opposed to manual cots. It was determined that the use of power transport cots would decrease the chance of injuries to employees. Although power transport cots are the best option, we believe that by purchasing one cot for each transport van we can allow for the option to use a manual cot when necessary.

The purchasing staff reviewed the quote. This purchase, two Stryker cots and a maintenance agreement for a total of \$98,635.06, is listed under the Medical Examiner's Department 2022 budget line 282650000-67125, Capital Assets over \$25,000.
