# Use of Excess Sales Tax to Cover Shortfall in Funding - Peace Trail Paving Project

**WHEREAS**, the Peace Trail is a 6.7 mile trail that connects the City of Janesville to Big Hill Park in the City of Beloit; and,

**WHEREAS**, the 2020-2025 Rock County Parks Outdoor Recreation Open Space (POROS) Plan recommends the paving of the Peace Trail; and

WHEREAS, the project is estimated to cost \$460,000; and

**WHEREAS**, Rock County Parks applied and has been awarded two Department of Natural Resources Stewardship 50/50 Grants totaling \$90,000, with a \$90,000 required match; and

**WHEREAS**, the City of Janesville will provide \$45,000 of the required grant match and a transfer of \$45,000 ATC funds is being requested for the County's share of the grant match; and

WHEREAS, multiple charitable donations have been secured totaling \$237,000; and

WHEREAS, the Department has a shortfall of \$43,000 in order to complete the paving of this trail; and,

WHEREAS, the request for the use of Excess Sales Tax funds to cover the shortfall in funding and allow the Parks Department to pave the Peace Trail from Janesville to Beloit.

**NOW, THEREFORE, BE IT RESOLVED** that the Rock County Board of Supervisors on this <u>24th</u> day of <u>March</u>, 2022, hereby approves the use of ATC funds of \$45,000 and Excess Sales Tax not to exceed \$43,000 for the use of paving the Peace Trail.

**BE IT FURTHER RESOLVED**, that the Parks Manager is hereby given the ability to award the contract in order to get the work completed by November 2022.

**BE IT FURTHER RESOLVED,** that the 2022 Parks budget be amended as follows:
