Awarding Contract for the Roof Replacement for the Tri Buildings A & B Roofs

WHEREAS, the budget included funds for the UW Extension Building A, Diversion Building B roof replacement; and

WHEREAS, Industrial roofing systems completed an analysis and found the shingled roof without adequate ventilation; and

WHEREAS, IRS recommended installing a metal roof as it will be the most cost-effective option based on the necessary changes required to correct the shingled roof ventilation; and

WHEREAS, Industrial Roof Services Inc. drafted the specifications; and

WHEREAS, bids were solicited and due to the supply chain and pricing vulnerability, we only received one bid; and

WHEREAS, the lowest, most responsive, and responsible bidder is Midwest Roofing and Construction LLC located in Dodgeville, WI, at the cost of \$289,000.00 for the Base bid plus \$8,600.00 for Alternate #2, which is the installation of a snow retention system in isolated areas along eaves, where shown in the Construction Drawings, for a total cost of \$297,600

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this <u>28th</u> day of <u>April</u>, 2022 does hereby approve and authorize awarding a contract in the amount of \$297,600.00 to Midwest Roofing and Construction LLC of Dodgeville, WI, for the Tri Buildings A & B roof replacement.

BE IT FURTHER RESOLVED, that a \$4,000.00 contingency will also be approved to cover any unforeseen items.

Funds were included in the 2022 budget for this project. The project is being funded with sales tax revenue.
