**BE IT FURTHER RESOLVED,** that a \$104,641.60 contingency also be approved to cover any unforeseen items.

These bid packets will be advertising seeking bids for each section or trades in the specifications. This is bid packet #1 which is for the footings and foundation work allowing for the foundation work to be completed prior to the 2022 winter months. Specific portions were drafted with Rock County Purchasing Advertising for bids. Bids were received and evaluated by Rock County Purchasing, Facilities Management and Construction Manager- Ben Bobzien. The lowest most responsive and responsible bidder was JP Cullen and Sons INC of Janesville in the amount of \$1,046,416.00

This is approving contracting with the lowest, most responsive, and responsible bidder, JP Cullen and Sons INC of Janesville in the amount of \$1,151,058.00. for the LES/Jail concrete and foundations.

This also provides a contingency fund of \$104,641.60 for any possible unforeseen items.
