**WHEREAS**, the electrical section 3.28A bid due date was extended to July 28, 2022; and

**WHEREAS**, Rock County received 2 bidders, which were evaluated by Rock County Purchasing, Facilities Management and Rock County Construction Manager; and

**WHEREAS**, the lowest, most responsive and responsible bidder was Westphal Electric of Janesville, WI in the amount of \$9,811,241.

**NOW, THEREFORE, BE IT RESOLVED**, that the Rock County Board of Supervisors duly assembled this 11th day of August, 2022 does hereby approve and authorize awarding a contract with Westphal Electric of Janesville, WI for \$9,811,241
