# Amending the 2022 Human Services Department Budget to Accept Substance Abuse Block Grant Supplemental Funding

WHEREAS, the Wisconsin Department of Health Services (DHS) has provided additional funding to supplement current substance use disorder prevention, treatment and recovery services, and address unmet needs or gaps in services in response to the COVID-19 pandemic; and,

WHEREAS, Rock County has received \$359,644 in additional funds; and,

WHEREAS, Rock County will use these funds to enhance and expand treatment and prevention resources in Rock County; and,

WHEREAS, Rock County will allocate funds for staff training about substance abuse; evidence-based curriculum materials; enhancing treatment through contingency management; child care for women while they attend treatment services; developing a peer specialist network to respond to urgent addiction needs; expanding prevention programs for youth; and system mapping to optimize programs and resources; and,

WHEREAS, this funding has no match requirement.

**NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board of Supervisors duly assembled this <u>15th</u> day of <u>December</u>, 2022, does hereby authorize the acceptance of Substance Abuse Block Grant Supplemental Funding.

#### **Executive Summary**

Amending the 2022 Human Services Department Budget To Accept Substance Abuse Block Grant Supplemental Funding

Wisconsin Department of Health Services (DHS) has provided grant funding to supplement current substance use disorder prevention; treatment and recovery services; and address unmet needs or gaps in services in response to the COVID-19 pandemic. This funding is in addition to the annual Substance Abuse Block Grant that occurs routinely.

Rock County has received \$359,644. The time-period for these funds is from 3/15/22 through 3/14/23. This funding is being used for specific projects that enhance treatment and prevention services within Rock County.

The projects include training more staff about substance abuse; purchasing evidence-based curriculum materials; enhancing treatment through contingency management; funding childcare for women while they attend treatment services; developing a peer specialist network to respond to urgent addiction needs (Wishope); expanding prevention programs for youth; and system mapping to optimize programs and resources (Epiphany).
