**Amending the 2023 Human Services Department Budget to Accept Additional Funding to Purchase and Manage Two Public Health Vending Machines**

**WHEREAS**, the Wisconsin Department of Health Services (DHS) has offered funding to purchase Public Health Vending machines and the Narcan necessary to stock the machine; and,

**WHEREAS**, Rock County Human Services has been awarded \$65,000 to be used for this purpose from July 1, 2023 to June 30, 2024; and,

**WHEREAS**, public access to Narcan is an effective harm reduction practice that saves lives; and,

**WHEREAS**, Rock County Human Services will purchase two vending machines to be placed in accessible public locations at two entrances of the DWRC.

**NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board of Supervisors duly assembled this 14th day of September, 2023, does hereby authorize the acceptance of \$65,000 in additional funding from the Wisconsin Department of Health Services to purchase public health vending machines and narcan necessary to stock the machines.
