Accepting Advancing a Healthier Wisconsin Endowment Seed Grant Funds and Amending the 2024 Rock County Public Health Department Budget

WHEREAS, the Medical College of Wisconsin is the administrator of the Advancing a Healthier Wisconsin *Seed Grant* Program, which provides funding through a competitive grant application to organizations aiming to improve health outcomes; and,

WHEREAS, the funding awarded to the Rock County Public Health Department is intended to build capacity of the Nutrition Collaborative of Rock County to address food access across the county; and,

WHEREAS, food access and food security influence mental and physical health, including chronic health conditions such as obesity, diabetes, and heart disease; and,

WHEREAS, Rock County Public Health Department outlined these concerns in a [Food Environment Report](#) that was released in April 2023; and,

WHEREAS, funding through the grant will be used to engage with residents of Rock County through community events and community conversations, host a community innovation event related to food security, and offer professional development opportunities to members of the Nutrition Collaborative aimed at enhancing skills necessary to carry out the collaborative’s work; and,

WHEREAS, the funding is for the time period of January 1, 2024 – December 31, 2024.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this 14th day of December, 2023 does hereby authorize Rock County Public Health Department to accept funding of \$36,345 through the Advancing a Healthier Wisconsin Endowment Seed Grant and amend the 2024 Rock County Public Health Department budget as follows:
