Awarding Bid for Correctional Healthcare Services at the Rock County Jail for 2025-2029

WHEREAS, funds have been incorporated into the 2024 Budget to contract with a private firm for inmate healthcare services at the Rock County Jail; and,

WHEREAS, Rock County requested sealed Proposals from healthcare providers to provide correctional healthcare services for inmates incarcerated in the Rock County Jail, with three firms responding; and,

WHEREAS, this request covered comprehensive correctional healthcare services including at a minimum physicians, nursing, sick call, medication dispensing, pharmaceuticals, TB testing, x-ray, mental health services, laboratory, off-site dental services, ambulance service, off-site hospitalization, blood draws and medical supplies; and,

WHEREAS, these comprehensive healthcare services will cover all costs associated with Rock County Jail inmate healthcare and treatment subject to the terms and limitations as outlined in the proposal and contract; and,

WHEREAS, the Proposals were reviewed by a panel consisting of Sheriff's Office personnel and purchasing staff with the recommendation to enter into a contract with VitalCore Health Strategies of Topeka, Kansas.

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this <u>28th</u> day of <u>March</u>, 2024, that a contract for correctional healthcare services for 2025 through 2029 be awarded to VitalCore Health Strategies of Topeka, Kansas in the annual amount of \$1,983,133.02 based on the terms and conditions set forth in the contract.

BE IT FURTHER RESOLVED that the contract may be extended for an additional 2 years.
