Accepting the Opioid Abatement Efforts by Law Enforcement Agencies Grant Funding and Amending the Sheriff's Office 2024 Budget

1 **WHEREAS**, the Sheriff's Office has been awarded a \$328,676.00 grant from the State of Wisconsin
2 Department of Health Services, Behavioral Health Section/Division of Care and Treatment Services;

5 **WHEREAS** the grant funding will be utilized to pay for treatment for people incarcerated in the Rock
6 County Correctional Facility with an opioid use disorder, in addition to providing awareness training for
7 law enforcement officers, correctional officers, and other facility staff; and,

9 **WHEREAS**, the Sheriff's Office has implemented a new program to address the issues of opioid usage
10 of individuals that are being held in custody in our correctional facility. The program addresses initial
11 assessment of individuals when entering the correctional facility, offering medications for opiate use
12 disorder, and providing individualized treatment, based on their identified treatment plan. This program
13 was initially implemented with Rock County Opioid Settlement Funds, for the medications needed to
14 begin the program, and will be expanded with this Opioid Abatement Grant Funding, which will provide
15 medical and counseling services, and staff training.

17 **NOW, THEREFORE, BE IT RESOLVED** by the Rock County Board of Supervisors duly assembled
