WHEREAS, the Sheriff's Office has implemented a new program to address the issues of opioid usage of individuals that are being held in custody in our correctional facility. The program addresses initial assessment of individuals when entering the correctional facility, offering medications for opiate use disorder, and providing individualized treatment, based on their identified treatment plan. This program was initially implemented with Rock County Opioid Settlement Funds, for the medications needed to begin the program, and will be expanded with this Opioid Abatement Grant Funding, which will provide medical and counseling services, and staff training.
